# A Message from Hank Seamon: 'Nothing Short of Miraculous'

Hiram,

I just returned to work after about six months of rehab and recovery. I opened my Lotus Notes and ran across the e-mail you were kind enough to send to my Kappa Sigma brothers on my behalf. You have no idea how touched and encouraged I was when I regained consciousness in March after a couple of weeks of being 'completely under' and was able to read the abundance of e-mails and cards wishing me well and letting me know folks were praying for me. One card that was especially dear to me was signed by all the current brothers at the Alpha Tau house. What thoughtfulness for someone they really don't even know — just that I was a brother in need.

I was in the hospital for 44 days. The viral meningitis test by spinal tap proved to be negative and was not a problem. But my fever was spiking to 105.9, my vital signs were all over the map, and they had to pack me in ice at one point. I was heavily sedated, and they had to intubate me to stabilize my condition.

The pneumonia was a staph infection of the nastiest sort and went septic: It got into the bloodstream, blocked all the capillaries and started shutting down organs. The doctors administered a Xygris drip, which has the risk of being fatal within the first few minutes and is only used as a last resort. Thankfully, I survived the first few minutes, but then my family had to wait out the next excruciating 96 hours before they knew if this would even work. It got down to the point that only my kidneys were hanging on, but thank God I made it through, and the doctors gradually brought me out of the anesthesia.

They'd had to save my life before they could begin to cure me. Even with all they did, the doctors and nurses called my survival nothing short of miraculous. In March of this year **Steve Norris** '71 sent an e-mail to those on his "brother list," asking for our prayers for **Hank Seamon** '74 who was at the time in the hospital with what was diagnosed as pneumonia, a staph infection and viral meningitis. It was mid-September before Hank was able to respond. Below is his e-mail to Steve.

Now the cure: The next 30 or so days included drawing about two liters of fluid out of my lungs by syringe, inserting a scope down into my lungs to remove some more stuff, a major thoracic surgery (likened to open-heart surgery and done by the same doctor), numerous chest tubes to drain off more junk outside the lungs and another scope down my throat to look at my heart. This with over 150 bags of IV antibiotics, two units of blood on four different occasions, and countless other IVs, blood work, etc., finally got me well enough for the doctors to say they wanted to get me out of the hospital before I caught something else. I went home and have continued to recover to this day. Now, after all this time, I am back to work.

I made it! I survived. A couple of people in very similar conditions, there in the same hospital, with the same doctors — one in a room right next to me — did not. This has all been a very sobering experience. I still am amazed and overwhelmed by the love and support that my family and I have received from our local church and from friends everywhere. Thank you! There were prayers being lifted on my behalf literally all over the world, through the use of the Internet to put me on various prayer chains. Oh, what a difference prayer makes!

I am eternally grateful to all of you who 'stood in the gap' for me. I am here today, almost fully recovered, and living proof that prayer works that our loving and caring God is faithful in giving His mercy and grace to those who know and call out to Him in Jesus's name.

Thank you and thank God!
